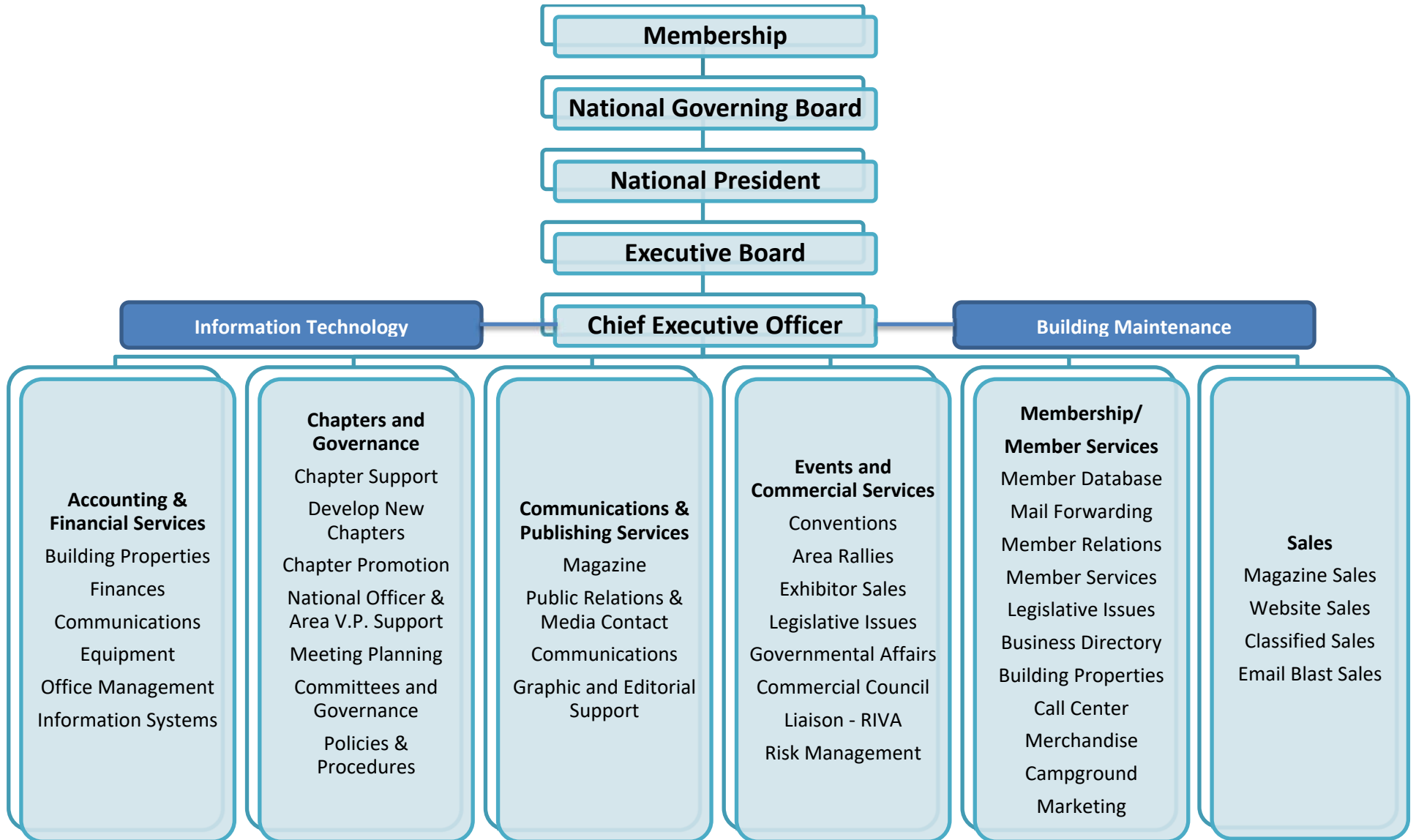


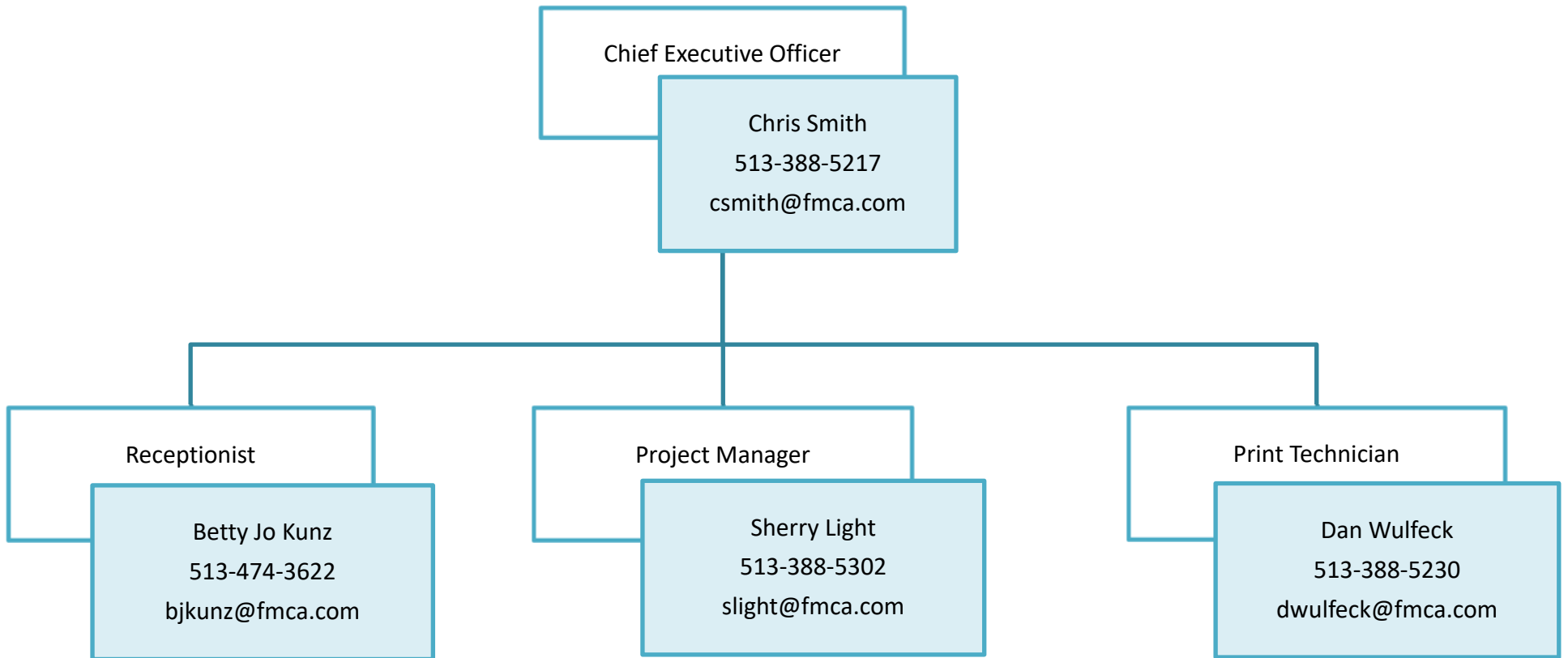
# FMCA NATIONAL OFFICE ORGANIZATION CHART
