To Governing Board Members,

The Constitution and Bylaws Committee met in January to review two proposals to amend the National Bylaws. The Bylaws amendments are among several items that will be voted on during the Governing Board meeting at the Lincoln, Nebraska, convention this summer. The proposals are included with this mailing for your review.

FMCA's Midwest Area National Vice President, Dennis Fox, resigned on March 22, 2022. We are in the process of filling this vacancy with a special election, with National Directors in the Midwest Area voting. This special election will be conducted by mail ballot. This term will be from June 2022 to August 2023.

Biannual elections are being conducted for the Area Vice President position in the Eastern, Great Lakes, International, Northwest, and Western areas. Successful candidates will serve on the Executive Board for a two-year term and take office during the Annual Membership Meeting in Lincoln, Nebraska, on August 27, 2022. A ballot and candidate details are included in this mailing for voting members in the respective areas.

The minutes from the Board of Directors and Executive Board meetings that were held in February also are included with this mailing.

FMCA's 105th International Convention and RV Expo will be held in Lincoln, Nebraska, at the Lancaster Event Center, August 24-27, 2022. The Governing Board meeting will take place at this event. Very shortly, your chapter secretary will receive a roll call sheet to verify the chapter officers and the voting delegate for this meeting. The meeting packet is expected to be mailed in mid-July. If you will be traveling during this period, please notify the chapter services staff at the national office that you will not be at your address of record to receive this packet, so other arrangements can be made.

We invite all chapter officers attending the Lincoln convention to an appreciation reception on Tuesday, August 23, 2022, at 2:00 p.m., in the Lincoln Room. We are looking



forward to the convention in Lincoln and want to show our appreciation for what you do to assist your chapters! Please join us. Additional details will follow in the next few mailings.
