# On behalf of the Convention Committee, Gary Milner moved to approve the Missouri State Fairgrounds in Sedalia, Missouri, for the 2024 Summer International Convention and RV Expo, pending successful negotiations. The motion was seconded.

Gary Milner noted that he and Doug Uhlenbrock conducted a recent site visit to Sedalia, Missouri. This location has been used for area rallies. They have 1,600 full-hookup sites and large buildings on the state fairgrounds. They have some concerns about the roadway leading into the property, since it is a small two-lane road, but the concern is manageable. This event would be held in the central United States. Gary also commented that he and Rodger Donnelly visited a site in Muskogee, Oklahoma, recently and noted that it would work for an area rally but not an International Convention. Gary also reported that there were no updates from the city of Redmond, Oregon. A recommendation was given to look at the Winnebago property in Forest City, Iowa. Doug stated that he had previously looked at the property in Forest City, and Lincoln, Nebraska, was chosen over Forest City because of the lack of buildings and infrastructure.

Gary reminded the Board that in 2023 the convention locations are Perry, Georgia, and Gillette, Wyoming. For 2024, Tucson was chosen as the winter site, and they will start negotiations for Sedalia, Missouri, for the summer site. Gary also noted that Newmar will be holding a rally in Sedalia prior to the FMCA rally in 2024. He also said that Airstream will be holding an event in Sedalia following the FMCA convention. The report was accepted for file. President Porter expressed his appreciation and thanked the Convention Committee for their efforts.

Under new business President Porter addressed the convention charity for Perry. He asked Doug Uhlenbrock for a report on the charities in the Perry area.

President Porter asked Doug Uhlenbrock to bring the charities forward so that the Board of Directors could rally behind the chosen charity. Doug reported that there were several options for the upcoming Perry event charity. Doug also noted that there are various ways to participate in the charity during the event. He noted that we need people to participate in the Magic Mile. He also commented that the auctioning of pies in Lincoln went very well.

Doug shared that the options include Abba House of Middle Georgia. This group supports women and children who are in a bad way or have fallen on hard times. Others are: Friends of Perry Animal Shelter; Family Promise of Greater Houston County, an organization that supports people experiencing homelessness; Genesis Joy House, an organization that shelters female veterans; or Halo Group, an organization that works with adults with disabilities.

# John Traphagen moved to select the Genesis Joy House, an organization that shelters female veterans, for the charity for the Perry, Georgia, International Convention and RV Expo. The motion was seconded.
