SUBJECT: 2023 Southeast Area National Vice President Election

In accordance with FMCA's Bylaws and Policies and Procedures, the National Directors representing the chapters in each designated area will nominate and elect by mail ballot their National Area Vice President. Each of the National Area Vice Presidents shall be elected for a two-year term. Please note the following procedures:

- ♦ Nominations are to be made on the enclosed form and received in the national office no later than **March 2, 2023**.
- On April 13, 2023, you will be sent a mail ballot listing all candidates for your area together with a return envelope, to be returned to FMCA's certified public accountants' office, postmarked no later than May 13, 2023. If you will be traveling during that time and you will not be able to receive the ballot at your address on file, please contact the Chapter Services Department at the national office, or e-mail chapters@fmca.com, to have the ballot sent to an alternate address.
- ♦ Each Chapter National Director and incumbent National Area Vice President has one vote in his or her area.
- ◆ The tabulation of the ballots will be done by FMCA's certified public accountants' office on May 23, 2023, and you will be notified of the election results.
