GOVERNING BOARD MEETING

You are hereby notified that the Governing Board will convene at 9:00 a.m., Wednesday, August 14, 2024, at the 109th International Convention and RV Expo in Redmond, Oregon. The meeting will be held in the First Interstate Bank Arena.

Registration begins at 7:30 a.m. We ask that you come no later than 8:30 a.m. to check in with the FMCA Review Council. This will provide ample opportunity to be seated by the time the meeting begins. Check-in will occur by **CHAPTER NAME**, which is printed on your white Registration Card.

When arriving for the Governing Board Meeting, you will see four lines: The first line will be for **Chapter names A – D and Executive Board**; the second line will be for **Chapter names E – L**; the third line will be for **Chapter names M – R**; and the fourth line will be for **Chapter names S – Z and Invited Guests**. Remember to bring the **white Registration Card** that is enclosed with the Governing Board booklet. Please present this card during the check-in process.

NATIONAL DIRECTOR AND CHAPTER DELEGATE'S WORKSHOP

Immediately following the National Directors' Briefing on Tuesday, August 13, in the First Interstate Bank Center, there will be a workshop for National Directors and Chapter Temporary Delegates in the same location. This workshop is scheduled to answer specific questions you may have prior to the meeting itself. You will not be restricted by a time limit. We ask that all voting delegates registered for Redmond attend this session.

PARKING ON THE GROUNDS

We suggest that all National Directors, Alternate National Directors, and Chapter Temporary Delegates who would like to attend the Area Caucuses, National Directors' Briefing, and Governing Board Workshop arrive on the grounds on Monday, August 12. If your Convention Confirmation Packet does not have an Arrival Date card dated August 12 or earlier, please call the Events Dept. at (800) 543-3622 to request an August 12 Arrival Card.

If you would like to meet with another Governing Board member so you can enter the parking area together, you should arrange to meet them before you arrive at the convention grounds or in the Welcome Area.

Please make sure your date of entry credential, which will be mailed to you along with your Convention Confirmation Packet, is visible when you enter the grounds.

If you have requested your Convention Confirmation Packet and/or your Governing Board Meeting Packet to be picked up at "Will Call," they will be available at Will Call beginning Saturday, August 10, 2024. These are different packets, so please let us know if one or both should be held at Will Call. When you arrive at the convention site, please advise the Parking Team that you are with the Governing Board and that your parking credentials are being held at Will Call in the Welcome Area. They will direct you to the appropriate location.

Governing Board participants can get transportation from the parking areas to the First Interstate Bank Center, on Tuesday and Wednesday, or they can drive their personal vehicles and park in the asphalt parking area of Lot D just outside the public gate. Follow signs for Public Gate/Passport Parking.

We hope you have a safe trip to and from Redmond, and we look forward to seeing you on Tuesday, August 13 for the pre-meeting activities and at the Governing Board Meeting on Wednesday, August 14. We appreciate your time and effort serving FMCA and your chapter. Thank you.
